**Skillful Memory Merchants reconstruct all historical records to tell the same lie.
The “Jew’s” lie then becomes the truth**

When a new history is needed to support a specific goal, it is quite easy to call in the “memory merchants,” the “gifted reconstructors of history,” who can skillfully exchange unwanted or unflattering truth for fiction. Then that new, fake history is promoted in history books and museums. Fake history is especially prevalent in textbooks; the upcoming generations must have truth removed before they will believe a lie.

History deals with books, not with things, a “patriotic” scholar might argue, having spent his or her entire life interpreting religious, governmental and ideological texts produced in the past by a paper-thin elite. This is true where the traditional study of the past is concerned. But the advent of anthropological history began, slowly but surely, to corrode the simplistic Zionist metahistories.¹

Probably one of the more important histories of the world was the new history, or lack of history, of the astounding great and powerful Khazar Kingdom. In his return letter to Dr. Goldstein, Mr. Freedman asks:²

Maybe you can explain to me, my dear Dr. Goldstein, the reason why and just how the origin and the history of the Khazars and Khazar Kingdom was so well concealed from the world for so many centuries? What secret mysterious power has been able for countless generations to keep the origin and the history of the Khazars and Khazar Kingdom out of history text-books and out of class-room courses in history throughout the world? The origin and history of the Khazars and Khazar Kingdom are certainly incontestable historical facts. These incontestable historic facts also establish beyond any question of doubt the origin and history of the so-called or self-styled “Jews” in eastern Europe. The origin and history of the Khazars and Khazar kingdom and their relationship to the origin and early history of the so-called or self-styled ‘Jews’ in eastern Europe was one of

history's best kept secrets until wide publicity was given in recent years to my research on this subject. Do you not think, my dear Dr. Goldstein, that it is time this whole subject was dragged out of its hiding place?³

The true history of the great and powerful Turkic Khazar Kingdom, the source of the Ashkenazi Jews, has been totally erased from world history by “expert memory-merchants” who rewrote history books according to what they wanted the world to believe.

True Biblical History gradually phased-out, or replaced

There is also pressure to impute to the New Testament charges of “hate,” with inevitable calls for the suppression of the Gospel of John or Matthew, or, failing that, the deletion -- or distortion through dishonest translation -- of those passages which offend the religious heirs of the Pharisees today as much as they did 2000 years ago. In a 1995 speech at Hebrew University, Cardinal Joseph Bernardin of Chicago blamed the Gospel of John for “inciting anti-semitism.” He initiated a dialogue concerning the possible need for its redaction or suppression. The rationale for censorship of certain “offensive” passages, or even the gradual phase-out of “obsolete” versions of the New Testament, such as the Douai-Rheims and King James, is the temporal chauvinist appeal to the phantasmagoria that due to the so-called “Holocaust,”¹⁷⁹ we have now entered a revolutionary new age, where we are duty-bound to scrutinize every traditional Western thought and action of the past 2,000 years in the light of whether or not these thoughts or actions may have contributed to making the “Holocaust” possible. History, art, politics, culture and language itself are deemed worthy and legitimate solely by the degree to which they represent a panegyric to Judaism. This sense of having entered a new order in relations with Jewish power and ideology has been brought about by the immense influence of the gargantuan, modern infotainment culture and “news” media network.⁴

Note what is being proposed: All “hate” passages against Orthodox Jews (they claim to be a continuation of the Pharisees of Christ’s day) found in the AV and in the Douai (Catholic version) must be gradually phased-out with new translations in order to protect the Talmudist’s imaginative view of history. “Jews” dominated the list of editors in Scofield’s book; Scofield’s notes placed Jewish Millennialism as a major plank in otherwise orthodox Christian doctrine.

It may safely be said that the Judaizing of the Church has done more to hinder her progress, pervert her mission, and destroy her spiritually, than all other causes combined. Instead of pursuing her appointed path of separation from the world and following the Lord in her heavenly calling, she has used Jewish Scriptures to justify herself in lowering her purpose to the civilization of the world, the acquisition of wealth, the use of an imposing ritual, the erection of magnificent churches, the invocation of God's blessing upon the conflicts of armies, and the division of an equal brotherhood into “clergy” and “laity.”⁵

We must agree with Scofield “that the Judaizing of the Church has done more to hinder her progress, pervert her mission, and destroy her spiritually, than all other causes combined.” However, the Word of God violently disagrees with Scofield’s removal of the Old Testament for any kind of justification for Christianizing the world.⁶ Though there have been dozens of essays, articles and chapters in history books devoted to the history of the Khazars and their connection to modern Jewish history, Israeli historians and publishers have blocked the paths to those books. Moreover, bookshops in Israel would not risk distributing

such books that were published in English.⁷

Honest History Forbidden

Abraham N. Poliak was born in 1910 in Kiev; he came with his family to Palestine in 1923. He occupied the Chair of Mediaeval Jewish History at Tel Aviv University and is the author of numerous books in Hebrew, among them a *History of the Arabs; Feudalism in Egypt 1250-1900; Geopolitics of Israel and the Middle East*, etc. His essay on “The Khazar Conversion to Judaism” appeared in 1941 in the Hebrew periodical *Zion* and led to lively controversies; his book *Khazaria* even more so. It was published in 1944 in Tel Aviv (in Hebrew) and was received with — perhaps understandable — hostility, as an attempt to undermine the sacred tradition concerning the descent of modern Jewry from the Biblical Tribe. His theory is not mentioned in the *Encyclopaedia Judaica* 1971-2 printing.⁸

Watch for library book sales, as they almost give away old “history” books because no one reads them. Those valuable books are replaced with false history, fluff and useless books that replace truth with lies and deceptions.⁹

For the mystery of iniquity doth already work: only he who now letteth will let, until he be taken out of the way. 8 And then shall that Wicked be revealed, whom the Lord shall consume with the spirit of his mouth, and shall destroy with the brightness of his coming: 9 Even him, whose coming is after the working of Satan with all power and signs and lying wonders, 10 And with all deceivableness of unrighteousness in them that perish; because they received not the love of the truth, that they might be saved. 11 And for this cause God shall send them strong delusion, that they should believe a lie: 12 That they all might be damned who believed not the truth, but had pleasure in unrighteousness. (2 Thes 2:7-12) Now the Spirit speaketh expressly, that in the latter times some shall depart from the faith, giving heed to seducing spirits, and doctrines of devils; 2 Speaking lies in hypocrisy; having their conscience seared with a hot iron; (1 Tim 4:1)

The natural man loves a lie over truth, and will seek every means possible to justify and support a lie. (Rev 22:15, *whosoever loveth and maketh a lie.*) He especially loves lies from his religious leaders. Why? *That they all might be damned who believed not the truth, but had pleasure in unrighteousness.*¹⁰

A New History

The Zionists needed a new history in order to lay claim to Palestine. Since the conversion of the Khazars, that effort has been led by Ashkenazi Jewish experts. The needed fake history is constructed by experts, and is commonly used to justify very unjust and evil causes. The “reconstructors of history” then publish their new and imaginative history, and it will be taught to following generations. As we have seen in our own US history, the new generations will accept the manufactured history as truth, and not only spend efforts and money, but may even voluntarily give their lives to defend the reconstructed history. As time passes, there is no memory of the truth, except what is kept alive by old books or hidden records.¹¹

Substituted History

Shelves in bookstores and university libraries in Israel hold countless volumes on subjects such as “the prehistoric Land of Israel,” “the Land of Israel under Crusader rule,” and “the Land of Israel under Arab occupation.” In the Hebrew-language edition of foreign books, the word “Palestine” is systematically replaced

with the words *Eretz Israel* (the Land of Israel). Even when the writings of important Zionist figures such as Theodore Herzl, Max Nordau, Ber Borochov, and many others — who, like most of their supporters, use the standard term “Palestine” (or Palestia, the Latin form used in many European languages at the time) — are translated into Hebrew, this appellation is always converted into the “Land of Israel.” Such politics of language sometimes results in amusing absurdities...¹²

That is, when the old books are translated from Hebrew, the word “Palestine” is systematically changed to “the Land of Israel” by the memory merchants, *i.e.*, those who are paid to form new, deceitful memories to support the Zionist’s cause.

The interest generated in the United States prompted the writing and publication of many new books and articles in English that focused upon the folkloristic aspects of the Haredim but unfortunately largely ignored their basic ideology and world outlook.¹³

Folklore: Orthodox Judaism admits that it is based on **folklore** — “The unwritten lore (stories and proverbs and riddles and songs) of a culture.” That is to say, the generated interest in Orthodox Judaism in the US has prompted the publication of books of “**Fairy Tales**” about the Jews. Their “Fairy Tales” are taught to Ashkenazi Jewish children at every opportunity, in order to assure their imaginary “Israelite” heritage will continue and strengthen. “The Haredi goal has obviously been to perpetuate their educational influence upon an increasing segment of younger generation Israelis.” As they perpetuate their Jewish “Fairy Tales” over the earth, they gain their needed influence into the Christian community. All Jewish education, which starts for the Jewish male children at about 3 or 4, stresses the study of the Talmud above everything else.¹⁴ Not only are history books rewritten, but books that reveal a truth about Judaism are not translated, or if they might be in English, they fall off the “shelf” as though they never existed:

Many Israeli Jews, who in their youth received thorough talmudic educations, have later in their lives reacted antagonistically against Orthodox Judaism's depiction and treatment of women. Some of these Jews in reaction have written articles that are often published in the Israeli Hebrew press but are **almost never translated into English**. Kadid Leper, for example, a well-known Israeli journalist who as a youth studied in a yeshiva for years before becoming a secularist, wrote in his April 18, 1997 Hai'r article under the title "Woman is a sack full of excrement..."¹⁵

Though anti-Zionist books by “Jewish” scholars are available in English, the authors are greatly maligned in hope that they will be ignored. The Zionist propaganda machine is very effective in their attempt to control history: **1)** it creates a new fake history, **2)** it replaces words to change history by rewriting history and text books, **3)** it removes true history books from public reach, &c. If the Jewish PR machine cannot control someone who does not support their Zionist’s cause, they will do all they can to undermine that person. Their power over world events lies in their ability to remain out of the public eye. One of Zionism’s arch enemies was Benjamin Freedman, and his writings. As soon as an anti-Zionist person gains any kind of a public attention, the Zionist PR machine goes into action to discredit any anti-Zionist voice, written or

spoken.¹⁶

The Wandering Jew is entirely the product of an imaginary history grown around the idea of the exile.

Although most of the professional historians knew there had never been a forcible uprooting of the Jewish people, they permitted the Christian myth that had been taken up by Jewish tradition to be paraded freely in the public and educational venues of the national memory, making no attempt to rebut it. They even encouraged it indirectly, knowing that only this myth would provide moral legitimacy to the settlement of the “exiled nation” in a country inhabited by others.¹⁷

Honest history proves that the true *homeland* of the *Ashkenazi Jews* is in the Caucasus Mountains. In order to accomplish the Zionist’s goals, truth had to be erased from world history, and replaced with an imaginative to support the Zionist’s cause. A new national myth had to be manufactured — a believable history in order to connect the *Children of Israel* that came out of Egypt with the *Children of Ashkenaz* who came out of the Caucasus Mountains. There is no connection this side of Noah. Through that manufactured false connection, the self-identified Jews followed their reconstructed history through Joshua and his conquering and possession of Canaan, “the Land of Israel,” or “the Promised Land.”¹⁸
