Introduction: This issue deals with the **1)** Biblical reason for, **2)** necessity of and **3)** what to expect from the Harris-Biden administration. **Amos 3:6** *shall there be evil in a city, and the LORD hath not done it?*

THE LAW OF THE BYSTANDER

The American Empire (birth, Nov, 1620. Death, Nov 2020) is now dead, and the vultures are circling in to pick the bones clean. Why?

As I was struggling to choose the proper articles for the January issue of the Examiner, I noticed that January contains “Sanctity of Life Sunday.” Over the years we have become an openly lawless society both inside and outside of the church. Here are excerpts from an interesting article:

THE SECRET TO SAVING AMERICA

David Kupelian explores how to fight the good fight without losing your soul:

...Summarizing America’s current spiritual state, Los Angeles mega-pastor John MacArthur recently told Fox News’ Laura Ingraham: “America’s in a moral free fall. ... You murder the babies in the womb. If they survive the womb, you try to seduce them into transgender sexual deviation when they’re young. If they survive that, you corrupt them with a godless education. If they survive that, you have divorce in the family. And if they grow to be adults, we drown them in a sea of pornography. This is a nation so far down in the sewer of immorality and wickedness that nothing surprises me.”

MacArthur is right, of course. Which means even if Trump miraculously remained in office for another four years and continued to turbocharge the U.S. economy as he did previously, America would remain in a state of “moral free fall.”

Indeed, no real and lasting recovery is possible for America without a genuine spiritual revival. ...

As Christians, we must realize that though Trump tried to stop the “moral free fall” with laws from the top down, and would have continued his efforts in a second term, the **“moral free fall” can only be stopped with the everlasting Gospel of Christ**; that is, conversion and transformation of the nations through preaching, teaching and the obedient application of the Law-word of God, *e.g.*, Ps 19.

GOD HAS ESTABLISHED an openly avowed Anti-Christ Harris-Biden administration to show that promotion comes only from Him. (Ps. 75:6) He is the one who establishes even the wicked in authority, Daniel 4:34-35, and all for His sovereign purpose and glory: *Thy kingdom come.*

The truth of what has been preached to the church for the last couple of generations is no longer theory, but reality:

Jeremiah 17:5 *Thus saith the LORD; Cursed be the man*

that trusteth in man, and maketh flesh his arm, and whose heart departeth from the LORD.

Trust in *the man*, Trump, is now as a vapor. Political movements have not given nor will they give life when the hearts of the Covenant people have departed from the Lord. Our only hope is a genuine turning to the Law of the Lord. How many times have we been told the true “secret of saving America”?

Hoshea 4:6 *My people are destroyed for lack of knowledge: because thou hast rejected knowledge, I will also reject thee, that thou shalt be no priest to me: seeing thou hast forgotten the law of thy God, I will also forget thy children. 7 As they were increased, so they sinned against me: therefore will I change their glory into shame.*

Lack of knowledge of His Law, providences, governments of the world, holy nature, hatred of sin, power to punish sin, &c. If his people had known *knowledge*, they would have repented and avoided His wrath, Psalms 19:7-11. **JFB**: “Their ignorance was willful...” **Geneva**: “the whole body of the people were weary with hearing the word of God.” **Barnes**: “God marks the relation between sin and the punishment” by telling them that their lawlessness brought their punishment upon them. They have no one to blame but themselves. **Finally**, why do they lack the *knowledge* that leads to repentance? **Poole**: “*Because thou*: the prophet now turns his words from the people to the priests among them.” Forgetting the *law of thy God* results in God forgetting the (Covenant) children. That is, the religious leaders have not taught and did not teach the Law and its implications to the Covenant people; thus, the law could not work in their hearts and bring repentance and obedience, and security in their land.

Hoshea 4:6 has been quoted many times as though it were a magic formula, yet with few exceptions, there has been no desire nor effort to teach, learn and follow the Law of God which alone leads to repentance, (Pro 28:13, 14) which is **the secret to saving America**. (No law, no repentance and no salvation. The results of Dispensational Armianism Antinomianism as promised by God upon an apostate people are upon us!)

January and the Sanctity of Life Sunday brought to mind one of the major laws that has been ignored, and has led to self-destruction; that is,

THE LAW OF THE BYSTANDER

In 1984, President Ronald Reagan issued a proclamation that established a National “Sanctity of Life

Day” in the United States. That day of remembrance of and commitment to protecting human life has been observed in churches throughout the country on the 3rd Sunday in January ever since. However, this year the 24th is closer to the “Roe v. Wade” decision.

We are members of the only Orthodox Reformed Church within an hour of us. It is a Presbyterian church maybe 30-35 min from us. Probably 50% of the group are Reformed Baptist who are in the same situation, as the closest Reformed Baptist church is probably two hours away.

The church is at least 90% homeschoolers who love children, and several parents work with the local *Crisis Pregnancy Center*. Our small congregation has at least three expectant mothers. Half of the congregation is made up of children who have been trained to sit quietly through the hour-long service.

The purpose of Sanctity of Life Sunday is to raise public awareness of the uncontrolled murder of children. We shall first consider **Proverbs 24**, and then **Psalms 50:16-2** as they present **The Law of the Bystander**.

WARNING: As we enter into a Harris-Biden administration, it may become costly to speak out against evil. From the pulpit, it will be much safer to speak soft, pleasant, pietistic words – words that will soothe the people, have no upsetting social application, avoid public censure, produce a good reputation in the community, and avoid the attention of a despotic authorities as they vigorously pursue their war against the God of Heaven (such now takes place in China and N Korea). Isaiah tells us that the result of those smooth words over the past decades are what have brought the wrath of God against His church. We are now living in the results.

Isaiah 30:10 *Which say to the seers, See not; and to the prophets, Prophecy not unto us right things, speak unto us smooth things, prophesy deceits:*

In other words, obeying the **Law of the Bystander** could well bring persecution by the wicked upon those who are seeking to obey it.

FIRST: Proverbs 24:10 *If thou be faint in the day of adversity, thy strength is small. [faint and avoid responsibility] 11 Deliver them¹ that are drawn to death,² and wilt thou not preserve them that are led to be slain?³ 12 If thou say, Behold, we knew not of it:⁴ he that pondereth the hearts, doth not he understand it? And he that keepeth thy*

*soul, knoweth he it not? Will he not also recompense every man according to his works?*⁵

¹ **when** it is in our power to do it lawfully. ² **unjustly**, or by the violence of lawless men. ³ **in** present danger of death or destruction. ⁴ **excuse** our non-involvement and neglect of duty with “I did not know...” when we did know (do we fail to look into evil around us because we do not want the responsibility to take a stand?) ⁵ **God** will certainly deal with thee as thou hast dealt with him, either rewarding thy performance of this duty, or punishing thy neglect of it. (Poole)

In other words, we cannot ignore the evils around us, e.g., abortion, and continue on as though it does not exist. The law of the bystander falls under the eighth commandment, THOU SHALT NOT STEAL. That law requires us to sound the alarm anytime a sin is being committed, and sin is defined by God’s law. (1 Jn 3:4) **Sanctity of Life Sunday** was and is meant to draw attention to those who are being delivered to death in the abortion mills.

Deuteronomy 22:1-4 shows us that God’s law works from the bottom up.

1 Thou shalt not see thy brother’s ox or his sheep go astray, and hide thyself from them: thou shalt in any case bring them again unto thy brother. 2 And if thy brother be not nigh unto thee, or if thou know him not, then thou shalt bring it unto thine own house, and it shall be with thee until thy brother seek after it, and thou shalt restore it to him again. 3 In like manner shalt thou do with his ass; and so shalt thou do with his raiment; and with all lost thing of thy brother’s, which he hath lost, and thou hast found, shalt thou do likewise: thou mayest not hide thyself. 4 Thou shalt not see thy brother’s ass or his ox fall down by the way, and hide thyself from them: thou shalt surely help him to lift them up again.

The law of the bystander requires one to help another’s animal when that animal is lost or in distress. If God’s law requires us to render proper care and warning about an animal belonging to friend or foe, how much more must we sound the alarm concerning the killing of the unborn?

Abortion falls under *Thou shalt not commit murder*, and I assume everyone agrees with that assessment. However, we are considering abortion under *Thou shalt not steal*, which holds the bystanders accountable before God. We, as **bystanders**, are to raise the alarm and sound out God’s word concerning the wickedness and evil that is going on around us. The **law of the bystander** is much broader than just murder. It applies to any evil of which we are aware, such as theft of company

tools, money or property.

If we do not publicly speak and stand against evil, we are held equally culpable before God as is the perpetrator. Obviously, we will not be held guilty as those are who are doing the wickedness, but we will be held accountable by God.

Deuteronomy 22:24 (*Then ye shall bring them both out unto the gate of that city, and ye shall stone them with stones that they die; the damsel, because she cried not, being in the city; and the man, because he hath humbled his neighbour’s wife: so thou shalt put away evil from among you.*) **tells us** that a woman assaulted in a city was presumed to have given her consent if she did not cry out. But if she was assaulted in the field, it was assumed that she cried out and no one heard her. In both cases, it was assumed that the bystander would have taken action to aid to the woman in distress. (It is not uncommon today to hear of **bystanders**, for whatever reason, ignoring one who is in distress. That bystander is just as guilty before God as is the one doing the violence: “I don’t want to get involved” will not justify one before God.) What are we doing to aid those in the distress of abortion? Support of the **Crisis Pregnancy Center** is a good means of aid.

God’s law considers the non-interfering bystander worse than those who give a false witness. The false witness misrepresents the truth, but the non-interfering bystander becomes an accomplice to the crime by failing to do what he could to stop the evil.

SECOND: Psalms 50:16 *but unto the wicked said God, What hast thou to do to declare mine ordinances, that thou shouldest take my covenant in thy mouth, 17 Seeing thou hatest to be reformed, and hast cast my words behind thee? 18 For when thou seest a thief, thou runnest with him, and thou art partaker with the adulterers. 19 Thou givest thy mouth to evil, and with thy tongue thou forgetst deceit. Thou sittest, and speakest against thy brother, and slanderest thy mother’s sons. 21 These things hast thou done, and I held my tongue; therefore thou thoughtest that I was like thee: but I will reprove thee, and set them in order before thee. 22 O consider this ye that forget God, lest I tear you in pieces, and there be none that can deliver you. He that offereth praise, shall glorify me: and to him that disposeth his way aright, will I show the salvation of God.*

1) v. 16, the Lord asks, “Why do you pretend to be my people and talk of my covenant, seeing that you are a wicked hypocrite? You say you are my people, yet you ignore the evil around you. You do not help

the victims; you do not challenge the evildoers, nor do you take steps that are within your power to at least hinder the evil doer.” Over the years, this writer has found, by experience, that *Letters to the Editor* are surprisingly effective weapons against the evil activities in one’s community. A well-written letter will normally get published. The *Letters to the Editor* are one of the most read section of the paper. However, there may be a price to pay for publicly standing against evil in high places.

How many claim to hold to Orthodox, Reformed Covenant theology yet they totally ignore the Law of the Covenant, the Ten Words and their broad implications, Psalms 119:96? (Deut 22, Ps 50, Mat 28:19, 20, &c., and Paul’s application in Rom 1:32.)

2) v. 17, *hatest to be reformed* (Geneva) *hatest’ instruction* (or reproof, KJV) Note how much stronger the Geneva is: *reformed*, or changed by God’s word, vs. *instruction*, or simply to be instructed by God’s word, though Biblically *instructed* does speak of *reformed* in thought and deed, but why change the word from its clear meaning? **God’s word calls for reformation** from sin to Him, and requires His people to do what they can against wickedness and for godliness. **Reformed**, that is, changed from indifference to active concern.

3) v. 18, the law of the Lord identifies the inactive bystander with the doer of the wicked deed. Certainly, our meager voice will not stop wicked activities such as abortion, for only a return to God’s command-word by God’s people will do that. But we cannot remain silent nor inactive against wickedness, or we shall stand equally guilty before the Law. **At the very least, we must know God’s law-word, and be ready always to give an answer in any matter at a moment’s notice, 1 Peter 3:15.**

4) Every Bible I have and all my commentaries give this cross reference for v. 18:

Romans 1:32 *Which men, though they knew the Law of God, how that they which commit such things are worthy of death, yet not only do the same, but also favor them that do them.*

What sharper condemnation can the Law speak to those who profess Christ yet they fail to **publicly speak** out against surrounding evil, abortion in this case, at every opportunity. (Again, I have found that *Letters*

to the Editor are a very effective means to speak out against evil.) The Law clearly identifies religious leaders, pastors/elders/teachers, or average self-professed Christians who fail to make a lot of “noise” against surrounding evils, the Law identifies them **with the evil doers**. According to the Law of the Lord, the silence of those who profess Christ makes them equally as culpable as the guilty evil doer. Moreover, refusing to address and confront social evils from God’s word delivers a “Christian” nation into the hands of the powers of darkness.

In **Romans 1:23**, Paul applies **Proverbs 17:15**, *He that justifieth the wicked, and he that condemneth the just, even they both are abomination to the LORD.*

Paul tells us that failure to publicly condemn the wicked means that we justify them, and reap our just reward from God.

In addition, **Proverbs 28:4** *They that forsake the law praise the wicked: but such as keep the law contend with them.* (**Contend** can mean things like physical war, verbal contending or righteous acts and words in the face of evil.) This is a hard saying, but failure to *contend* with the wicked means we have forsaken *the law* and we *praise the wicked*.

When I was pastor in Linden, a young lady in Lafayette became very upset over the evils in her community. She became angry enough to start a small tabloid. She was able to get enough sponsors to publish the paper. In it, she documented who, what, when and the circumstances around many wicked activities in Lafayette. Her biggest distress was that NO LOCAL pastor would write articles addressing the evils from God’s Law, so she came to me to write some articles. **We are now living the God-ordained results of decades of self-professed Christians**, be they pastors/elders, religious leaders in general or an average professed Christian, either because they do not know Scripture, or because they fear what man might do to them, have failed and are failing to teach the implications of God’s law-word, and publicly address social problems from Scripture, especially from the pulpit to God’s people who gather to hear applications of the *the law of the Lord*. The Law of the Lord clearly identifies those who remain silent as wicked hypocrites. Notice He is speaking to His Covenant people in Psalms 50 when He said: *but unto the wicked said God, What hast thou to do to declare mine ordinances, that thou shouldest take my covenant in thy mouth...* They profess to be His covenant people,

but remain silent against the wicked actions going on around them.

“But, Bro Need, you do not have to face the results of publicly speaking against evil from the pulpit. You speak now with pen and ink.”

Over the years as a pastor in IN and in WV, I have paid the price for speaking out against the surrounding evils. I have personally found that making a lot of public noise from Scripture about the wicked activities in one’s community will gain the label of being a radical and one to be avoided.

In WV, a son-in-law of one of the church members was in the drug enforcement arm of the State Police. They were warned against radicals, and their description matched what I was doing and saying publicly against the evils in our county. He told me that I was not at all like what was being portrayed as a radical. I found that my “radical” views against wickedness attracted a large following among those who were being trod under foot by the “rich and powerful.” I had filled the wrong paperwork to present to a judge to be able to get the public financial records of the local Chamber of Commerce, an ideal place for the rich to get richer. On my way out of the court room, an attorney told me what paperwork to file. He later joined us pro-bono in our very expensive fight all the way to the WV Supreme Court over the County Commission violation of the “Sunshine Law.” Though he was full-fledged pagan, I enjoyed working with him, and he tolerated my witnessing to him; I made it clear that my motive was to protect my neighbor’s property. The “good old boy” network resulted in a loss at the SC. His fees would have amounted to better than \$100,000. Though I have never promoted it, nor do I keep it up, <https://www.facebook.com/HardyCountyInformed/> has 1,514 “likes,” and 1,506 followers. Various lawyers around WV also found it useful, as it records our fight with the local gods. My anti-PC stand provided the help of the local News Paper, which started out with Letters to the Editor, and a one hour TV interview show on the local TV station. The same with www.biblicalexaminer.org when I took a public stand against a Ponzi scheme (Greater Ministries) being promoted by a very popular pastor. All my local pastor friends became enemies, yet

several state attorney-generals used my articles to move against and jail the founders of the Ponzi.) I kept my war against the local anti-christs outside of the pulpit, except for teaching the Word as it might apply to local situations.

Obeying The Law of the Bystander could well be very costly for a pastor, the cost will show up in attendance, in the offering plate, in public ridicule, or even cost him his church, for we live in a fallen world. But do we answer to the Law of the Lord, or to public opinion? Fear God or Fear man? How many godly men have been snared away from obeying God by the fear of man? (Pro 29:25.)

At the very least, we must speak out against evil at every opportunity. We must speak God’s Word, and not ours. I tell folks, “Make

God the ‘bad guy. Make the disagreement between the person and God.’”

Let us be reminded of some familiar and well-used passages. Both **Ezekiel 3 & 33** are quite clear on the fact that God holds us responsible to speak out and warn the wicked at every opportunity:

33:8 When I shall say unto the wicked, O wicked man, thou shalt die the death, if thou dost not speak and admonish the wicked of his way, that wicked man shall die for his iniquity, but his blood will I require at thine hand.

On the positive side:

V. 9, Nevertheless, if thou warn the wicked of his way to turn from it, if he do not turn from his way, he shall die for his iniquity, but thou hast delivered thy soul.

His blood, thy soul... How can these things be concerning the Covenant people? As fallen creatures, we cannot know nor understand these deep things of God. However, *blood* and *soul* imply serious accountability. King Lemuel, or Solomon, was told this by his mother:

Proverbs 31:8 *Open thy mouth for the dumb in the cause of all such as are appointed to destruction.*

His mother told him that he had a responsibility to speak for those who could not speak for themselves. Is our responsibility any less?

5) Paul’s warning:

1 Timothy 5:22 *Lay hands suddenly on no man, neither be partaker of other men’s sins; keep thyself pure.*



The Law forbids hastily placing unproven men into teaching position. Violation of this Law has serious results for the church and for society in general. (Note that it must be the Law of the Lord, and NOT the law of men that qualifies men for their position in His service.) When and if we see violation and do not speak out, we become partakers with them in their evil.

Deuteronomy 19:19 (*Then shall ye do unto him, as he had thought to have done unto his brother: so shalt thou put the evil away from among you.*) implies that the silent, inactive bystander is under the same penalty as the one committing the violation of the Law. “But the **law of the bystander** is Old Testament. We are New Testament Christians.”

First, the Law pronounces curses against those who

try to divide up God's word into various dispensations: Deuteronomy 4:2, Proverbs 30:6, Revelation 22:18, 19. **Second**, our Lord condemned those who sought to justify their inaction:

Luke 10:29 *But he willing to justify himself, said unto Jesus, Who is then my neighbor? 30 And Jesus answered, and said, A certain man went down from Jerusalem to Jericho, and fell among thieves, and they robbed him of his raiment, and wounded him and departed, leaving him half dead. 31 Now so it fell out, that there came down a certain Priest that same way, and when he saw him, he passed by on the other side. 32 And likewise also a Levite, when he was come near to the place, went and looked on him, and passed by on the other side. 33 Then a certain Samaritan, as he journeyed, came near unto him and when he saw him, he had compassion on him, 34 And went to him, and bound up his wounds and poured in oil and wine, and put him on his own beast, and brought him to an Inn, and made provision for him 35 And on the morrow when he departed, he took out two pence, and gave them to the host, and said unto him. Take care of him and whatsoever thou spendest more when I come again, I will recompense thee. 36 Which now of these three, thinkest thou, was neighbor*

unto him that fell among the thieves? 37 And he said, He that showed mercy on him. Then said Jesus unto him, Go, and do thou likewise.

Christ summed up the law of the bystander in the above parable of the Good Samaritan. In His condemnation of the religious leaders, He clearly condemned those who in this **Gospel Age** ignore or do not take appropriate action when possible, or do not clearly and publicly speak against the surrounding wickedness.

Let me close with this word:

Deuteronomy 21:18 *If a man have a stubborn and rebellious son, which will not obey the voice of his father, or the voice of his mother, and that, when they have chastened him, will not hearken unto them: 19 Then shall his father and his mother lay hold on him, and bring him out unto the elders of his city, and unto the gate of his place; 20 And they shall say unto the elders of his city, This our son is stubborn and rebellious, he will not obey our voice; he is a glutton, and a drunkard. 21 And all the men of his city shall stone him with stones, that he die: so shalt thou put evil away from among you; and all Israel shall hear, and fear.*

This law is exceedingly broad, but we will only consider one point.

Normally, it took 2 or 3 witnesses and a judicial inquiry for the death penalty to be applied. Yet here, only the parents' word was required: it is assumed that the situation was as the parents said, or they would not have brought him to the elders. In this law, we see that there is a limitation upon the power of the family—the family cannot take the life of a child, though it could seek blood-vengeance.

Man's law says that it is the “legal” right for parents to take the life of their child, which is forbidden by God's law. It is significant that those who are against capital punishment are for abortion:

Ps 94:21 *They gather themselves together against the soul of the righteous, and condemn the innocent blood.*

They condemn the innocent and free the guilty, e.g., the US poured multiplied billions of dollars into Communist China, and now we are surprised that China used those billions to conquer America as they purchased the 2020 election. (China is building coal-fired power plants worldwide while their representatives in the US are shutting down coal-fired plants. They are investing in their effort to control the world.) David said, “*As saith the proverb of the ancients, Wickedness pro-*

ceedeth from the wicked...” (1 Sa 24:13) It is impossible for the wicked to think straight, or to think or do other than wickedness.

In the surrounding pagan cultures of Old Testament days, including Rome, the father had the state’s authority to kill his own children. God forbid that practice. But most importantly, the family here in Deuteronomy 21:18 is required to side with God’s law against their own flesh and blood. If the parents refused to bring the complaint against their *stubborn and rebellious* son, they were guilty of condoning or participating in his crimes.

By God requiring family justice against the son and heir, then it was obvious that justice is required against daughters, family members and surrounding neighbors. Self-professed Christian parents, even pastors and elders, failure to enforce the Law concerning their children is a reason God’s hand is so heavy against the church. Christians refuse to side with God’s word against the ungodly, particularly their own children. They have made the ungodly their gods.

We are now moving into what may be a very lengthy period of living with the results of Christian neglect of surrounding evils, and standing by with little or no comment.

The failure to publicly speak out in, and failure to speak, and those results are not going to be pleasant. (My dad, a Baptist lay pastor, determined to be so detached that he refused to even read the newspaper. He did not want to even know about the surrounding evil. I did pay attention until I became friends with a lady member of the Birch Society after I got out of the service.)

Though our attention turns to the plague of abortion in January, our neglect of the surrounding evils has caused God’s face to turn against our beloved nation. We must know what God’s word says about the evils around us, and seek opportunities to speak God’s word of condemnation in due season.

The secret to saving America has NEVER been a secret:

Ecclesiastes 12:13 ¶ *Let us hear the conclusion of the whole matter: Fear God, and keep his commandments: for this is the whole duty of man. 14 For God shall bring every work into judgment, with every secret thing, whether it be good, or whether it be evil. Romans 14:12* So then every one of us shall give account of himself to God.

The Law of the Bystander. There is no hope other than repent and obey the commandments of God. Both Zechariah 7:10 and Malachi 3:5 pronounce judgment on God’s covenant people for not speaking out against the oppressive gods and speaking for those oppressed. A GENERATION THAT KNEW NOT GOD

JUDGES 2:10-13

The principles of God’s Word are eternal principles and when these are violated there is the occurrence of endpoint eschatology. That principle is: “Do this evil and receive divine retribution.” The LORD God commanded Adam, “Of every tree of the garden thou mayest freely eat: But of the tree of the knowledge of good and evil, thou shalt not eat of it: for in the day that thou eatest thereof thou shalt surely die” (Gen. 2:16-17). Adam’s disobedience brought spiritual and physical death into the human race. The first two sons born to Adam and Eve showed that what Adam did in disobeying God had set a precedent in their family. How do we know? Cain slew his brother Abel because God accepted Abel’s worship via the proper sacrifice and rejected Cain’s worship which did not meet God requirements, but Jehovah God gave Cain another opportunity to bring a proper offering for in essence God said, “If you bring the proper sacrifice you will be accepted” (Gen. 4:7). No! He did not bring the acceptable offering for he did not repent!

This principle was true for an individual or for a nation. Consider it from a national perspective. “And

there arose another generation after them, which knew not the LORD, nor yet the works which he had done for Israel. GOVERNMENT SCHOOLS ARE KILLING THE AMERICAN CHURCH

Over the last few generations, Christianity has declined at a massive rate in America, with millennials becoming the first generation in American history with self-proclaimed Christians in the minority. Now, the culprit is becoming clear to everyone: Government. In particular, anti-Christian, anti-God indoctrination masquerading as “public education” has been the key driver of those trends.

While it is a widely held misconception that government schools became more secular as the culture did, the reality is that the “public education” system was always intended to turn Americans against God. Indeed, it was created for that purpose. And it has been phenomenally successful in pursuing that goal, with most Christian children abandoning the faith after more than a decade in a public “school.”

According to a massive report headlined “Promise and Peril: The History of American Religiosity and Its Recent Decline” from the neoconservative American Enterprise Institute, the record is clear on the issue. It is not urbanization, or more education, or the progress of “science,” or even more welfare spending, that has so thoroughly de-Christianized America and the rest of the Western world.

Instead, the data and the historical record show that the more tax money a secular government spends on

“education,” the more the public will turn away from God. “Childhood religiosity was heavily affected by government spending on education,” wrote AEI researcher Lyman Stone in his report, perhaps stating the obvious.

“Thus, while more educated people were not less religious, societies that spent more public money on education were less religious,” Lyman found. “It is not educational attainment per se that reduces religiosity, but government control of education and, to a lesser extent, government support for retirement.”

Other researchers have theorized that simply receiving more “education” could explain the trend away from faith and Christianity. However, researchers Raphael Franck and Laurence Iannaccone, who studied the issue in depth, noted that “higher educational attainment did not predict lower religiosity: More and less educated people are similarly religious.”

Similarly, the move toward cities and industrialization could not explain the trends either. Ironically, the two researchers found the opposite. “A more urban and industrialized population was associated with greater religiosity,” the report states, adding that even government welfare largely taking the place of churches supporting the poor did not explain the catastrophic plunge in religiosity.

Indeed, according to Lyman, who also cites other researchers, secularized education provided by government that banishes any mention of God “can explain nearly the totality of change in religiosity.” As he puts it, “increasingly secularized government control of education ... can account for virtually the entire increase in secularization around the developed world.”

This is exactly what Scripture warns of. “Train up a child in the way he should go; even when he is old he will not depart from it,” reads Proverbs 22:6. Jesus warned in Luke 6:40, “A disciple is not above his teacher, but everyone when he is fully trained will be like his teacher.” And yet American Christians continued to send their children to anti-Christian government schools.

The fruit is clear, too. Since 1960, the report says, the share of American adults who attend any religious service has plunged from half to about a third. Meanwhile, the share who say they are members of any religious body has fallen from over 75 percent to just 62 percent. And the number of Americans who identify with any

religion has plunged from over 95 percent to just 75.

This was deliberate, of course. “The decline in religiosity in America is not the product of a natural change in preferences, but an engineered outcome of clearly identifiable policy choices in the past,” the AEI report explains, again stating the obvious.

This writer has investigated those policy choices in depth. It began with anti-Christian Communist Robert Owen in the early 1800s, who created what whistleblower Orestes Browson described as a “secret society” to promote the then-radical idea that government should “educate” children.

Horace Mann and John Dewey, the architects of America’s government “education” system, also used “public school” to wage war on Christianity and individual liberty. The outrageous 1962-1963 Supreme Court rulings against Bible and prayer in school merely formalized the revolution and put the final nails in the coffin.

Decades after sensible conservative leaders such as E. Ray Moore of Exodus Mandate began sounding the alarm and calling for Christians to leave government schools, even the Big Government neo-”conservatives” at the anti-Trump National Review have finally caught on.

“For religious conservatives who care about the fate of American culture, it cannot be emphasized enough that education is the whole ball game,” wrote Cameron Hilditch in NRO in an article about the AEI report. “All other policy areas amount to little more than tinkering around the edges.”

“The time has come for religious parents to take their children back from the state,” he concluded. “It simply will not do anymore for faithful Americans to drop their sons and daughters off at the curbside every morning for the government to collect as if they were taking out the trash.... the only real road to religious revival is the one that begins with each parent’s first step out of the public school’s doors.”

Finally, the fact that government schools have brainwashed generations of Americans against God and the church is becoming too obvious to hide. Whether it is too late to turn the tide in America and the rest of the West remains to be seen. But at this point, what is clear is that religious parents of all faiths must run for the exits of the government indoctrination system — now.

THE MAYFLOWER COMPACT

(November, 1620)

The In the name of God, Amen. We whose names are under-written, the loyal subjects of our dread sovereign Lord, King James, by the grace of God, of Great Britain, France, and Ireland King, Defender of the Faith, etc.

Having undertaken, for the glory of God, and advancement of the Christian faith, and honor of our King and Country, a voyage to plant the first colony in the north-

ern parts of Virginia, do by these presents solemnly and mutually, in the presence of God, and one of another, covenant and combine our selves together into a civil body politic, for our better ordering and preservation and furtherance of the ends aforesaid; and by virtue hereof to enact, constitute, and frame such just and equal laws, ordinances, acts, constitutions and offices, from time to time, as shall be thought most meet and convenient for the general good of the Colony, unto which we promise all due submission and obedience. In witness whereof we have hereunder subscribed our names at Cape Cod, the eleventh of November [New Style, November 21], in the year of the reign of our sovereign lord, King James, of England, France, and Ireland, the eighteenth, and of Scotland the fifty-fourth.

Anno Dom. 1620.

Observe the stated purpose for settling of this land:

First: “for the glory of God, and the advancement of the Christian faith.”

Second: to establish a land ruled by just and equal laws, and ordinances as needed for the good of the Colony.

The stated purpose was soon forgotten, and we see where we are today.

The covenant God asked His Covenant people, “*And shall ye possess the land?*” The answer is no. (A covenant can be broken, but the terms of that covenant cannot be changed. Read the covenant.) MASS EXODUS FROM PUBLIC SCHOOLS ACCELERATES

The exodus of families from government schools continues to accelerate nationwide, sparking panic among the education establishment that has so badly failed America's children. And the trends are not just because of COVID, contrary to government claims.

Now, public-school bigwigs are freaking out about what the plunge in enrollment means for their bloated taxpayer-funded budgets. In short: The government "education" gravy train is about to get a lot smaller as sensible families flee to the safe sanctuary of homeschooling and private schools.

The numbers are huge. Massachusetts public schools lost almost 40,000 students this fall. New York public

schools lost over 30,000. Fairfax County, Virginia, lost almost 10,000, while the Los Angeles Unified School District lost 11,000. Some districts have lost over 10 percent. Enrollment at colleges and universities dropped by more than 15 percent over 2019 levels. And the exodus continues to grow.

Countless government-school officials are warning — falsely — that the looming declines in their budgets will supposedly hurt children. If and when the pandemic ends, they claim, there will be a rush to re-enroll children. However, the facts, data, and trends suggest the exodus will keep picking up steam with or without coronavirus.

Consider that while government-school advocates are frantically trying to blame COVID19 for the fleeing families, many of the trends were actually being observed long before the virus struck.

In Massachusetts, for example, the Massachusetts Association of School Superintendents reported a 5 percent decrease in enrollment since coronavirus. However, the ongoing exodus began well before COVID shut down schools.

"It may be the virus, or it may be a real systemic issue that we're seeing some significant drop of pre-K students coming into the district," Worcester School Committee member Jack Foley was quoted as saying by local media reports.



Despite efforts to portray the exodus as solely a response to COVID and the limitations of virtual learning, the reality is that there is much more to the story. FreedomProject Academy, an online school affiliated with FreedomProject Media, has hit new records and saw an explosion of growth during COVID — and it is all virtual.

One of the key issues is growing awareness about the dangers of "public education" to children. With government schools becoming increasingly radical in the indoctrination and sexualization of America's youth, the movement to liberate children and families from the nightmare has gone from the fringes to mainstream in recent years.

Many of America's most prominent and respect-

ed leaders have urged parents to ditch government schools. Talk-show host Rush Limbaugh, for instance, who is heard by close to 20 million listeners each day, has repeatedly called on his audience to protect their children from public “education” by getting them out. In response to the LGBT extremism in New Jersey, evangelical leader Franklin Graham also urged parents to get their children out.

Even President Trump, who has the fervent support of perhaps 100 million Americans or more, has repeatedly emphasized the need to protect children from “failing government schools.” During his Independence Day speech at Mt. Rushmore, the president even pointed out — correctly — that the mayhem in America’s streets was a direct result of indoctrination by government schools.

According to a recent report in the New York Times on the exodus from public schools, enrollment in private schools is actually up, too. And as The Newman Report reported recently, the number of homeschool families has more than doubled just since last year, with more than 10 percent of all families with school-age children now educating them at home.

Families are doing the right thing by fleeing the government indoctrination system posing as an “education” system. **However, as the exodus picks up speed, educational totalitarians will do everything possible to crush the movement and the freedom that enables it. Advocates of educational liberty must be prepared for the coming war.** (War for their own children, we must add.)

EVERYTHING IS BROKEN

In the summer of 2014, I gave birth to a baby boy. He was born with a perfect Apgar score, after a very easy delivery. But my labor had not been smooth—in fact, throughout the day and a half of contractions, I believed there was something decidedly wrong. I also felt that way as I held him for the first time, and he writhed violently under my hands. In a video taken about 10 minutes after he was born, he can be seen lifting his head up off my chest. “Ooooh, look at how advanced he is!” someone can be heard trilling in the background, before her voice is overtaken by my own. “Don't do that, love,” I say. Then, to the camera: “Does he seem like he's in pain to you?”

It took my husband and me three years to understand that in fact I was right that day in the delivery room. Our son was hurt. And it will take him years to heal—longer than it should have, and that is on top of the injustice of the original wound—though I thank God every day that we figured it out.

The first breakthrough came when my husband David remembered a book about brain science he had read a decade earlier, by a doctor named Norman Doidge. It changed our lives, by allowing us to properly understand our son's injury (and to understand why we couldn't manage to get a straight answer about it from any of the “experts” we had seen). It's been a tough road, but from that moment on, we at least knew what to do—and why.

A year or so later, we met Doidge and his wife, Karen,

for dinner, and it is here that the story may become pertinent for you.

After we ordered, I told Norman I had a question I'd been wanting to ask—and that I wanted his honest answer to it, even if it meant that I had done something wrong. I proceeded to relay to him the entire tale, from the very beginning to that very moment, of what felt to me like our Kafkaesque medical mystery journey.

How was it, I then asked, that it took my husband and me—both children of doctors, both people with reporting and researching backgrounds, among the lucky who have health insurance, and with access through family and friends to what is billed as the best medical care in the country—years to figure this out, and that in the end we only did so basically by accident?

Norman looked at us sympathetically. “I don't know how else to tell you this but bluntly,” he said. “There are still many good individuals involved in medicine, but the **American medical system is profoundly broken**. When you look at the rate of medical error—it's now the **third leading cause of death** in the U.S.—the **overmedication**, creation of addiction, the quick-fix mentality, not funding the poor, quotas to admit from ERs, **needless operations**, the monetization of illness vs. health, the monetization of side effects, a peer review system run by journals paid for by Big Pharma, the destruction of the health of doctors and nurses themselves by administrators, who demand that they **rush through 10-minute patient visits**, when so often an hour or more is required, and which means that in order to be ‘successful,’ doctors **must overlook complexity** rather than search for it ... Alana, the unique thing here isn't that you fell down so many rabbit holes. What's unique is that you found your way out at all.”

I had barely started processing this when Norman moved to change the subject: “Now, can I ask you two something? How come so much of the journalism I read seems like garbage?”

Oh, God.

David and I looked at each other, simultaneously realizing that the after-school special we thought we were in was actually a horror movie. If the medical industry was comprehensively broken, as Norman said, and the media was irrevocably broken, as we knew it was ... Was *everything* in America broken? Was education broken? Housing? [Farming](#)? [Cities](#)? Was [religion](#) broken?

Everything is broken.

Let's say you believe the above to be hyperbolic. You never fell through the cracks of the medical system; as far as you understand it, there are plenty of ways for a resourceful person to buy a home in America these days; you easily met a mate and got married and had as many children as you wanted, at the age you wanted to have them; your child had a terrific time at college, where she experienced nothing at all oppressive or bizarre, got a first-class education that you could easily afford and which landed her a great job after graduation; you actually like the fact that you haven't encountered one book or movie or piece of art that's haunted you for months after; you enjoy druggily floating through one millennial pink space after another; it gives you pleasure to interact only with people who agree with you politically, and you feel filled with meaning and purpose after a day spent sending each other hysteria-inducing links; maybe you've heard that some kids are cosplaying Communism but that's only because everyone is radical when they're young, and Trump voters are just a bunch of racist troglodytes pining for the past, and it's not at all that neither group can see their way to a future that looks remotely hopeful ... If this is you, congratulations. There's no need to reach out and tell me any of this, because all you will be doing is revealing how insulated you are from the world inhabited by nearly everyone I know.

If, on the other hand, the idea of mass brokenness seems both excruciatingly correct and also paralyzing, come sit with me. Being on a ship nearly 4 million square miles in area along with 330 million other people and realizing the entire hull is pockmarked with holes is terrifying.

But being afraid to face this reality won't make it less true. And this is the reality.

For seven decades, the country's intellectual and cultural life was produced and protected by a set of institutions—universities, newspapers, magazines, record companies, professional associations, cultural venues, publishing houses, Hollywood studios, think tanks, etc. Collectively, these institutions reflected a diversity of experiences and then stamped them all as “American”—conjuring coherence out of the chaos of a big and unwieldy country. This wasn't a set of factories pumping out identical widgets, but rather a broad and messy jazz band of disparate elements that together produced something legible, clear, and at times even beautiful when each did their part.

But, beginning in the 1970s, the economic ground underneath this landscape began to come apart. Michael Lind explains this [better than anyone else](#):

The strategy of American business, encouraged by neoliberal Democrats and libertarian conservative Republicans alike, has been to lower labor costs in the United States, not by substituting labor-saving technology for workers, but by schemes of labor arbitrage: Offshoring jobs when possible to poorly paid workers in other countries and substituting unskilled immigrants willing to work for low wages in some sectors, like meatpacking and construction and farm labor. American business has also driven down wages by smashing unions in the private sector, which now have fewer members—a little more than 6% of the private sector workforce—than they did under Herbert Hoover.

This was the tinder. The tech revolution was the match—one-upping the '70s economy by demanding more efficiency and more speed and more boundarylessness, and demanding it everywhere. They introduced not only a host of inhuman wage-suppressing tactics, like replacing full-time employees with benefits with gig workers with lower wages and no benefits, but also a whole new aesthetic that has come to dominate every aspect of our lives—a set of principles that collectively might be thought of as [flatness](#).

Flatness is the reason the three jobs with the most projected growth in your country all earn less than \$27,000 a year, and it is also the reason that all the secondary institutions that once gave structure and meaning to hundreds of millions of American lives—jobs and unions but also local newspapers, churches, Rotary Clubs, main streets—have been decimated. And flatness is the mechanism by which, over the past decade and with increasing velocity over the last three years, a single ideologically driven cohort captured the entire interlocking infrastructure of American cultural and intellectual life. It is how the Long March went from a punchline to reality, as one institution after another fell and then entire sectors, like journalism, succumbed to control by narrow bands of sneering elitists who arrogated to themselves the license to judge and control the lives of their perceived inferiors.

Flatness broke everything.

The reigning aesthetic of the 20th century was modernism, which articulated in one word the values of the industrial revolution. Modernism and the Machine Age

brought with them their own features: Anti-classicism; anti-Victorianism; the power of science; the absence of filigree; an emphasis on the future over the past, and the valorization of machine production and engineering as the highest forms of human creativity. This new aesthetic soon began to transform all parts of cultural and material existence, from visual art and poetry to fashion and the built environment.

Starting in the second decade of the 1900s, certain Communists began seeing in modernism a potential advertisement for the values of a mass society of industrial workers laboring under the direction of a small group of engineers. In other words, this aesthetic—which whole swaths of the Western world were already in the process of quickly adopting—could also be the perfect delivery mechanism for their political ideology.

One hundred years later, we find ourselves in the middle of a similar cultural and political struggle.

Today's revolution has been defined by a set of very specific values: boundarylessness; speed; universal accessibility; an allergy to hierarchy, so much so that the weighting or preferring of some voices or products over others is seen as illegitimate; seeing one's own words and face reflected back as part of a larger current; a commitment to gratification at the push of a button; equality of access to commodified experiences as the right of every human being on Earth; the idea that all choices can and should be made instantaneously, and that the choices made by the majority in a given moment, on a given platform represent a larger democratic choice, which is therefore both true and good—until the next moment, on the next platform.

Here's a description of the [aesthetics of Silicon Valley](#) (emphasis added):

It's the realm of coffee shops, bars, startup offices, and co-live/work spaces that share the same hallmarks everywhere you go: a profusion of symbols of comfort and quality, at least to a certain connoisseurial mindset. Minimalist furniture. Craft beer and avocado toast. Reclaimed wood. Industrial lighting. Cortados. Fast internet. The homogeneity of these spaces means that traveling between them is *frictionless*, a value that Silicon Valley prizes and cultural influencers take advantage of. Changing places can be as painless as reloading a website. You might not even realize you're not where you started.

“You might not even realize you're not where you

started.” The machines trained us to accept, even chase, this high. Once we accepted it, we turned from willful individuals into parts of a mass that could move, or *be* moved, anywhere. Once people accepted the idea of an app, you could get them to pay for dozens of them—if not more. You could get people to send thousands of dollars to strangers in other countries to stay in homes they’d never seen in cities they’d never visited. You could train them to order in food—most of their food, even all of their food—from restaurants that they’d never been to, based on recommendations from people they’d never met. You could get them to understand their social world not as consisting of people whose families and faces one knew, which was literally the definition of social life for hundreds of thousands of years, but rather as composed of people who belonged to categories—“also followed by,” “friends in common,” “BIPOC”—that didn’t even exist 15 years ago. You could create a culture in which it was normal to have sex with someone whose two-dimensional picture you saw on a phone, once.

You could, seemingly overnight, transform people’s views about anything—even everything.

The Obama administration could swiftly overturn the decision-making space in which Capitol Hill staff and newspaper reporters functioned so that Iran, a country that had killed thousands of Americans and consistently announces itself to be America’s greatest enemy, is now to be seen as inherently as trustworthy and desirable an ally as France or Germany. *Flatness, frictionlessness.*

The biological difference between the sexes, which had been a foundational assumption of medicine as well as of the feminist movement, was almost instantaneously replaced not only by the idea that there are numerous genders but that reference in medicine, law or popular culture to the existence of a gender binary is actually [bigoted](#) and [abusive](#). *Flatness.*

Facebook’s longtime motto was, famously, “Move fast and break shit,” which is exactly what Silicon Valley enabled *others* to do.

The internet tycoons used the ideology of flatness to Hoover up the value from local businesses, national retailers, the whole newspaper industry, etc.—and no one seemed to care. This heist—by which a small group of people, using the wiring of flatness, could transfer to themselves enormous assets without any political, legal or social pushback—enabled progressive activists and

their [oligarchic funders](#) to pull off a heist of their own, using the same wiring. They seized on the fact that the entire world was already adapting to a life of *practical flatness* in order to push their ideology of *political flatness*—what they call social justice, but which has [historically meant the transfer of enormous amounts of power and wealth to a select few](#).

Because this cohort insists on sameness and purity, they have turned the once-independent parts of the American cultural complex into a mutually validating pipeline for conformists with approved viewpoints—who then credential, promote and marry each other. A young Ivy League student gets A’s by parroting intersectional gospel, which in turn means that he is recommended by his professors for an entry-level job at a Washington think tank or publication that is also devoted to these ideas. His ability to widely promote those viewpoints on social media is likely to attract the approval of his next possible boss or the reader of his graduate school application or future mates. His success in clearing those bars will in turn open future opportunities for love and employment. Doing the opposite has an inverse effect, which is nearly impossible to avoid given how tightly this system is now woven. A person who is determined to forgo such worldly enticements—because they are especially smart, or rich, or stubborn—will see only examples of even more talented and accomplished people who have seen their careers crushed and reputations destroyed for daring to stick a toe over the ever multiplying maze of red lines.

So, instead of reflecting the diversity of a large country, these institutions have now been repurposed as instruments to instill and enforce the narrow and rigid agenda of one cohort of people, forbidding exploration or deviation—a regime that has ironically left homeless many, if not most, of the country’s best thinkers and creators. Anyone actually concerned with solving deep-rooted social and economic problems, or God forbid with creating something unique or beautiful—a process that is inevitably messy and often involves exploring heresies and making mistakes—will hit a wall. If they are young and remotely ambitious they will simply snuff out that part of themselves early on, strangling the voice that they know will get them in trouble before they’ve ever had the chance to really hear it sing.

As with Communists and modernism, there was nothing inevitable about the match. Most consumers don’t know that by using internet-based (or -generated)

platforms—by buying from Amazon, by staying in an Airbnb, by ordering on Grubhub, by friending people on Facebook—that they are subscribing to a life of flatness, one that can lead directly into certain politics. But they are. Seduced by convenience, we end up paying for the flattening of our own lives. It is not an accident that progressive ideas spread faster on the internet. The internet is a car that runs on flatness; progressive politics—unlike either conservatism or liberalism—are flatness.

I'm not looking to rewind the clock back to a time before we all had email and cellphones. What I want is to be inspired by the last generation that made a new life-world—the postwar American abstract expressionist painters, jazz musicians, and writers and poets who created an alternate American modernism that directly challenged the ascendant Communist modernism: a blend of forms and techniques with an emphasis not on the facelessness of mass production, but on individual creativity and excellence.

Like them, our aim should be to take the central, unavoidable and potentially beneficent parts of the Flatness Aesthetic (including speed, accessibility; portability) while discarding the poisonous parts (frictionlessness; surveilled conformism; the allergy to excellence). We should seek out friction and thorniness, hunt for complexity and delight in unpredictability. Our lives should be marked not by “comps” and metrics and filters and proofs of concept and virality but by tight circles and improvisation and adventure and lots and lots of [creative waste](#).

And not just to save ourselves, but to save each other. The vast majority of Americans are not ideologues. They are people who wish to live in a free country and get along with their neighbors while engaging in profitable work, getting married, raising families, being entertained, and fulfilling their American right to adventure and self-invention. They are also the consumer base for movies, TV, books, and other cultural products. Every time Americans are given the option to ratify progressive dictates through their consumer choices, they vote in the opposite direction. When HBO removed *Gone with the Wind* from its on-demand library last year, it became the #1 bestselling movie on Amazon. Meanwhile, endless numbers of Hollywood right-think movies and supposed literary masterworks about oppression are dismal failures for studios and publishing houses that would rather sink into debt than

face a social-justice firing squad on Twitter.

This disconnect between culturally mandated politics and the actual demonstrated preferences of most Americans has created an enormous reserve of unmet needs—and a generational opportunity. Build new things! Create great art! Understand and accept that sensory information is the brain's food, and that Silicon Valley is systematically starving us of it. Avoid going entirely [tree-blind](#). Make a friend and *don't* talk politics with them. Do things that generate love and attention from three people you actually know instead of hundreds you don't. Abandon the blighted Ivy League, please, I beg of you. Start a publishing house that puts out books that anger, surprise and delight people and which make them want to *read*. Be brave enough to make film and TV that appeals to actual audiences and not 14 people on Twitter. **Establish a newspaper, one people can see themselves in and hold in their hands.** Go back to a house of worship—every week. Give up on our current institutions; they already gave up on us. (We do not offer much in Examiner, but it is what we can do. Pray for us, and support as the Lord leads, *ed.*)

At the lowest point with my son—the moment when I was convinced something was deeply wrong, and that I would never be able to fix it—my husband found himself on a reporting trip, where he encountered the head of an illustrious yeshiva. I had been sending David desperate texts all afternoon, and at one point his own anguish became obvious. “What's your son's name?” the rabbi asked, and David told him it was Elijah. “Ah, the prophet of unlikely redemption,” he said, smiling. “With them, the good news is almost as hard as the bad.”

It took me a while, but I eventually figured out what he meant. Sometimes the task of rebuilding—of accepting what has been broken and making things anew—is so daunting that it can almost feel easier to believe it can't be done.

But it can.

Everything IS broken! Use extreme caution about going to a hospital; it can be one of the most dangerous places one can go, particularly during this plandemic. A positive Covid test (with no symptoms at all, and up to 95% false positives) can quarantine you in there for 10

or more day.

As you know, Bettie is going through breast cancer treatments. Every third week, she must go to the UC (University of Cincinnati) Ohio University hospital which is about 75 minutes from us. That chemo infusion takes 4-6 hours, which means I must wait there.

Then the following Monday, she goes back for a shot to strengthen her bone to increase the white blood cell count. The goal is to get the two tumors small enough for a simple lumpectomy along about the end of February. That first week after the infusion, there is no appetite, but by the end of the third week she can even eat at the local Ponderosa.

We were told that half way through the treatment, they would check her heart. They did an echogram on January 7th, then the infusion Friday, the 8th. Then we went back for her bone shot on the 11th. We were about ½ way home on the 11th, when they called us back to the ER, saying they had found evidence of a blood clot in her heart from the 7th echogram. We went back the 11th, and they immediately, without confirming it was a clot, started her on heparin, a powerful blood thinner they inject into the belly of those who must lay in bed. (I have had a few of those.) I was allowed with her in the ER even without a mask, and then they did the Covid test. (She had just tested negative on January 1st.) The test came back positive, so they quarantined her, and I was unable to be with her when they moved her to a room from the 11th until they released her the 16th. (My daughter lives about 15 min away from the hospital across the Ohio river, so I was able to spend the 5 days and nights with them, which saved over three hours a day travel.) When pressed, even the nurses admit that Covid is simply a bad case of the flu, and it is a game forced upon them. When they continued to keep us in the dark, and I could not see her, I accused them of quarantining her until she died so they could collect the \$33,000 reward for reporting a “Covid” death. (Then after 5 days in bed, they did not provide a wheel chair to take her out to meet me.)

The heparin caused major problems, including messing up her blood count. It caused bleeding into her intestines. They wanted to do a GI test to see why there was bleeding, so she could not eat for a day. They did not try to confirm the “clot” for three days, and when a MRI revealed no evidence of a “clot,” they removed the heparin. **Questions:** Was it a **false reading** on the first Echogram? **Did the Lord** heal it? Did the Lord use the

false reading to draw attention to the H.Pylori? **Did the heparin** dissolve it? Our problem is that they did not do a second test to confirm the “clot” for three days, and then they stopped the heparin, and the bleeding into the intestines stopped. But the heparin had done its damage, including serious “clouding” her mind and weakness. She came home totally “wiped out,” weaker than a kitten, and after 5 days confined to bed, very unsteady on her feet. She was totally disoriented, and unable to find her way in our house, nor could she stand on her own. It was the GI examination revealed H.Pylori, a major infection she probably picked up living in Brazil. Normally, H.Pylori lies dormant, but Chemo has created serious problems with it. Tetracycline has been used many years to treat H.Pylori, as has been HQ, and is freely available in Brazil to deal with the H.Pylori. However, it is \$500 for a 14 day series here in the States.

In the ER, they started the heparin without talking to us; they did not tell us of the side effects of that massive dose of heparin, and would not respond as Bettie asked them to confirm the clot. (They were even talking of heart surgery to remove the clot.) We continually asked what was taking place, but no one would tell us as they just proceeded with the normal protocol for a blood clot.

I have had my share of hospital visits, Military and Civilian, and if I do not question what they are doing, the staff voluntarily explains the procedure, and makes sure we understand. But we were in such a “state” with the threat of a blood clot in the heart that we did not question their normal protocol, though we did not know what it was. The heparin not only messed up her gut, but had a serious effect on her memory. She is gaining some strength (and memory) back as I make her get up and walk. We pray that the Lord in his mercy will see fit to reverse the destruction caused by those who are PRACTICING medicine. Their practice did not work well on my wife. **CONCLUSION:** Question everything, and learn the details. Every hospital I have been in has told us what was going on, and expected side effects. Cincinnati area: Beware of the University of Cincinnati hospital. (They did not even wheel her out, but made her walk a good way to get out after 5 days in bed. We certainly let our feeling be known to the doctor, and he agreed that they should have confirmed a clot much sooner than they did.) Normally, the first week after the infusion, she is unable to eat. This time it was worse. She is 76 on 2/23. The Lord hears

and answers prayer.

The involved details of the doctor who did read the follow-up instructions from the echogram in the ER as well as details as to how well we are progressing in this ordeal will be at *biblicalexaminer.org*. Lord willing, I hope to update it every few days.

PRINTER PROBLEM

Background: Those who have followed the Examiner since the 1990s know that I used to print the Examiner in the Linden Baptist Church basement where the Lord provided the means to do everything in house, from the photo ready layouts to the 11x17 printed page from an offset press. (I enjoyed learning new skills,

such as the offset press printing process, and producing a nice looking printed page.) When we moved to VA, the Examiner went to tabloid. Due to expense of the inefficient USPS, we had to reduce to e-mail, with few exceptions. Switching to e mail cut our mailing list by probably 3/4th and left no money for printing. (We still do hard copies upon special request, and print hard copies to make available at various locations, as well as to print my various books. 12 sheets for each 24-page publication takes a heavy-duty printer, as does multi-page books.)

Having to leave behind the offset printing press when we moved, we searched for a good heavy duty duplex printer, and found a HP 4650dn on eBay with only 45,000 pages on it--duty cycle, 80,000 a month. No one uses that many sheets per month, but 80,000 reflects its heavy-duty design. Now, 15 years later and with only 250,000 (500,000 not unusual) copies on it, it refuses to feed properly. There is a repair man in Covington KY (TechCastle, excellent source for new and used custom designed PCs and use Macs) who used to service the 4650 back in the late 1980s and worked my on the 4650 a couple of times. We are at the point where the part needed in the feed tray is not to be found. It is computer controlled, and if the feed tray does not provide the proper information, it will not feed, though it still produces good images.

So, we must replace the 4650, and there will be no hard copy until we get a replacement, Lord willing, a HP CP4005DN, duty cycle 80,000. Both the 4650 and the 4005 weigh 65-70 lbs. Toner for out of date printers can be found at great cost savings over ebay.)

Conclusion: I was going to try to coax another issue out of the 4650, and waited to publish until I could get a hard copy printout, but that will not happen. The PDF email is not affected, so here is the the January issue without the corresponding hard copy at this time.

WHO HAS THE POWER?

WE QUICKLY FORGET WHAT REAL POWER IS

Back in the days of the late Roman Empire, a monk journeyed from his home in rural Asia Minor (now Turkey) to visit the great city of Rome. Out of curiosity, he joined a crowd headed into the Coliseum. After finding a seat, he was horrified to see men fighting each other to the death for spectators' amusement.

He staggered down the steps and into the ring, thrust himself between the gladiators, and cried out, “Friends, for Christ’s sake, forbear!” One of the combatants ran the defenseless man through with his sword. As the little monk bled to death on the sand, the jeering crowds fell silent, stunned and shamed. First in a trickle, then in a flood, they poured out of the Coliseum, whose arena was never stained with human blood again.

Here’s the more accurate version of the story, as recorded by Bishop Theodoret of Syria (ca. 425): An ascetic named Telemachus, while visiting Rome, was shocked by the gladiatorial games. His effort to put a stop to them enraged the crowd, who stoned him to death. It appeared that Telemachus had only enhanced the entertainment that day, until Emperor Honorius heard the story and was moved to ban the games.

Even if that version of the story is not entirely true, it’s a historical fact that gladiatorial games ended during the reign of Honorius, and Telemachus may well have been the inspiration. The “little monk” represents a profound principle that entered the Western world around a.d. 33—that raw power was not the controlling ethos of life on earth.

Christianity claimed kings and kingdoms, rewrote laws, and sparked revolutions the world over.

That’s the theme of historian Tom Holland’s book *Dominion: How the Christian Revolution Remade the World*. Before Christ, it would have been inconceivable that a religion based on the sacrificial and shameful death of a god—a religion that obligated its adherents to the same kind of humility—would have made any inroads at all. But in time, Christianity claimed kings and kingdoms, rewrote laws, and sparked revolutions the world over. It planted in Western conscience the concept of human rights, obligations to the poor, and defense of the weak. Through weakness, in fact, Christ had conquered the world.

But what happened to power? Obviously it’s still with us. The abuse of power is what Western civilization is all about, according to critical-theory scholars. While they’re right in much of the detail, they’re wrong in substance. Oppression is not limited to the West. According to Nietzsche, the primal urge of all life is to discharge its strength—the “will to power,” usually understood as force or manipulation.

But everyone has some measure of strength to discharge, even if it’s only over oneself. Everyone has a

degree of power, and the ability to determine how to use it: squandered in brute force, or made perfect in the “weakness” of Christ?

Reading Revelation this month, I was struck by the image of the Lamb that was slain, who alone is worthy to open the scroll of judgment (Revelation 5:6-9). With it, He receives power, wealth, wisdom, might, honor, glory, and blessing.

“All authority in heaven and on earth has been given to me,” He told His followers (Matthew 28:18). In the interval between His departure and His return, that power is devoted to building His Church, as the Church builds His kingdom (“Therefore, go and make disciples”).

But afterward, His power is exercised in judgment. Every murderous tyrant, every destructive war, every natural disaster, will pale in comparison to the havoc brought by the gentle Lamb, crowned in John’s vision with seven horns symbolizing His perfect strength.

In the current chatter about white supremacy and oppression and microaggression, we’ve lost a sense of what real power is. When the weak win against the strong through the humility of early saints like Telemachus, Christ calls out, “For My sake, forbear!” When the script of judgment is passed to the Lamb, and the seals broken, no one will stand except by Him.
